What is it?

The Policy primarily covers overseas medical expenses outside the insured person's country of domicile. It also extends to cover ancillary expenses such as optical, dental, physiotherapy and other similar expenses as well as pregnancy cover* which includes pre-natal, post-natal, routine, emergency maternity and newborn child expenses.

Emergency medical evacuation is also included for persons based outside Australia. This cover applies if an insured person cannot access appropriate medical care when based in a developing country, enabling their return to Australia or their country of domicile if this is not Australia.
