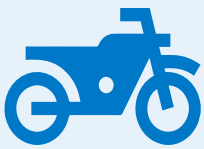




## 5 of DUAL's biggest Corporate Travel claims in the past 12 months



**A 50-year-old woman sustained a fractured pelvis and multiple injuries after being knocked from the motorbike she and her husband were riding in the U.S.**

The customer underwent extensive surgery and, once deemed fit to fly, was repatriated back to Australia. The total claim amounted to AUD 200,000, covering medical expenses, surgery, and repatriation costs.

**Claim Paid: AUD200,000**



**A 35-year-old man sustained a fractured neck vertebrae from an e-scooter fall while in the U.S.**

Following the accident, the customer underwent surgery and received comprehensive medical treatment. Once he was deemed fit to fly, he was safely repatriated back to Australia. The total claim paid amounted to AUD 270,000 covering all medical expenses and repatriation costs.

**Claim Paid: AUD270,000**



**A 55-year-old man recently underwent gall bladder surgery and, due to unforeseen complications, required an urgent medical evacuation from a remote island in the Pacific Ocean.**

The complexity and urgency of the situation were handled promptly, with the total claim amounting to AUD 188,000 fully covered.

**Claim Paid: AUD188,000**



### A 65-year-old man experiencing severe dizziness and general malaise sought treatment at a medical centre.

After a thorough evaluation and extensive testing, he was diagnosed with acute dyspnoea, kidney injury, and congestive heart failure. His condition required immediate and intensive care. Following the diagnosis, a claim was processed and paid out for AUD 140,000 to cover his medical expenses.

**Claim Paid: AUD140,000**



### A 60-year-old man suffered a fractured pelvis in a skiing accident.

Following the incident, he was hospitalised and received comprehensive medical care. Once he was deemed fit to travel, he was safely repatriated to Australia. The total claim amounted to AUD 255,000, covering his medical expenses and repatriation costs.

**Claim Paid: AUD255,000**
